## Trump administration orders halt of NYC toll meant to fight traffic and fund mass transit

NEW YORK (AP) — President Donald Trump's administration on Wednesday ordered a halt to New York City's congestion pricing system, which thins traffic and funds mass transit by imposing high tolls on drivers entering some parts of Manhattan.

Launched on Jan. 5, the city's system uses license plate readers to impose a \$9 toll on most passenger cars entering Manhattan neighborhoods south of Central Park. In its early days, transit officials say the toll has brought modest but measurable traffic reductions.

That charge comes on top of what drivers already pay to use bridges and tunnels to get onto the island. Drivers who take a tunnel in from New Jersey during peak commuting hours now pay \$31.81, or a discounted rate of \$22.06 if they are enrolled in the E-ZPass toll collection program.

Similar tolling programs intended to force people onto public public transit by making driving cost-prohibitive have long existed in other global cities, including London, Stockholm, Milan and Singapore, but the system had never before been tried in the U.S.

Trump, whose namesake Trump Tower penthouse and other properties are within the congestion zone, had vowed to kill the plan as soon as he took office. He previously characterized it as a massive, regres-

"It will be virtually impossible for New York City to come back as long as the congestion tax is in effect," Trump said in November as New York prepared to implement the plan before he took office.

Revenue from the tolls is intended to raise billions of dollars in revenue for the city's creaky and cashstrapped transit system, which carries some 4 million riders daily.

The tolling system has been divisive.

Transit advocates and en-

vironmentalists have heralded it as an innovative step to reduce air pollution from vehicle exhaust, make streets safer for pedestrians and bikers, while speeding up traffic for vehicles that truly need to be on the road, like delivery trucks and police cars.

But the high tolls are hated by many New Yorkers who own cars, particularly those that live in the suburbs or parts of the city not wellserved by the subway system.

New Jersey Gov. Phil Murphy, a Democrat, had fought the tolls and court and wrote a letter Trump on Inauguration Day imploring him to kill the program.

New York Gov. Kathy Hochul also had misgivings. Last June, she abruptly halted the tolling system's planned launch, citing concerns about its impact on the local economy. The Democrat then revived the toll in November following Trump's election, but reduced the toll for passenger vehicles from \$15 to \$9. Since then, she has lauded it as a win for the city and has discussed the issue multiple times with the president.

The tolling plan was approved by New York lawmakers in 2019, but stalled for years awaiting a required federal environmental review during Trump's first term before being approved by the administration of President Joe Biden. As in other cities, the New York congestion fee varies depending on the time and the size of the vehicle. Trucks and other large automobiles pay a higher rate, and the fee goes drops to \$2.25 for most cars during the quieter overnight hours. The toll survived several lawsuits trying to halt it before its launch, including from the state of New Jersey, unionized teachers in New York City, a trucking industry group and local elected leaders in the Hudson River Valley, Long Island and northern New Jersey.

# Trump administration labels 8 Latin American cartels as 'foreign terrorist organizations'



WASHINGTON (AP) — The Trump administration is formally designating eight Latin American crime organizations as "foreign terrorist organizations," upping its pressure on cartels operating in the U.S. and on anyone aiding them.

The move, carrying out a Jan. 20 executive order by President Donald Trump, names Tren de Aragua in Venezuela, MS-13 in El Salvador and six groups based in Mexico. The designation will be published in Thursday's edition of the Federal Register, according to a notice Wednesday.

Trump, a Republican, has made securing the U.S.-Mexico border among his top priorities, vowing to carry out mass deportations, sending active duty reaching deals with some countries to take in more migrants.

Critics of the move call it an unnecessarily broad and harsh one that could damage relations and paralyze trade with Latin America. Businesses, banks and buyers could fear possible U.S. prosecution if they knowingly or unknowingly have any transactions that touch the world of the cartels.

Such cartels permeate Mexico's economy, dealing not only in drug trafficking and migrant smuggling but in fighting for control of the multibillion-dollar avocado business.

Aid groups say some past U.S. designations of groups as foreign terrorist organizations have threatened overall food imports into countries, for example, by making shipping companies fearful that U.S. prosecutors may accuse them of directly or indirectly supporting the targeted groups.

Mexican President Claudia Sheinbaum said Wednesday before the designations were published that "if that decree has to do with extraterritorial actions (in Mexico), those we do not accept."

# Senate confirms Kelly Loeffler, former Georgia senator, to lead **Small Business Administration**

**WASHINGTON (AP)** — The U.S. Senate on Wednesday confirmed Kelly Loeffler, a Georgia businesswoman and former senator, to lead the Small Business Administration, returning a stalwart supporter of President Donald Trump to Washington.

At SBA, Loeffler will oversee the entity that describes itself as the only Cabinet-level federal agency "fully dedicated to small business" by providing "counseling, capital, and contracting expertise as the nation's only go-to resource and voice for small businesses."

Typically, the agency which was founded in 1953 offers Economic Injury Disaster Loans to help meet working capital needs caused by a disaster, loans that can be

used to pay fixed debts, payroll, accounts payable and other expenses that would have been met if not for the disaster.

The Senate confirmed Loeffler on a 52-46

Loeffler, who co-chaired Trump's second inaugural committee, served briefly in the U.S. Senate in the final year of the president's first term. Appointing her to the Senate to fill out the term of Johnny Isakson, Georgia GOP Gov. Brian Kemp touted Loeffler as a successor in the Republican's moderate mold.

But facing an immediate reelection campaign in 2020, Loeffler hewed closely to Trump to stave off challengers from her right flank, characterizing herself as "more conservative than Attila the Hun."

# California judge pulled a gun and shot his wife during an argument, prosecutor says

SANTA ANA, Calif. (AP) — A Southern California judge pulled a loaded gun from his ankle holster and fatally shot his wife during an argument while the couple was watching television, a prosecutor told jurors as the judge's trial got underway Wednesday.

Superior Court Judge Jeffrey Ferguson had been drinking on Aug. 3, 2023, when he argued with his wife, Sheryl, during dinner at a local restaurant and later while watching "Breaking Bad" at home with their adult son, prosecutor Seton Hunt said.

At one point in the evening, Ferguson made a gun hand gesture toward his wife, and she later chided him to point a real gun at her, Hunt said.

Ferguson proceeded to point a gun and pulled the trigger, Hunt said. He was later taken into custody by police and, in comments captured on a video recording, pleaded for a jury to convict him.

"I killed her," Ferguson is heard saying on the recording. "I did it."

Ferguson, 74, has pleaded not guilty, and his lawyer

contends the shooting was Ferguson sat in court as an accident.

Wednesday's statements came at the beginning of Ferguson's trial on a murder charge in the shooting death of his wife in a case that has roiled the legal community in Orange County. To avoid a conflict of interest, a Los Angeles County judge is presiding over the case before jurors in the Orange County city of Santa Ana not far from where Ferguson previously heard cases in his courtroom.

a defendant and wore a gray suit jacket and glasses. His lawyer, Cameron J. Talley, reserved his opening statement for later in the trial, but previously said the shooting was accidental, not murder.

Ferguson and his adult son called 911, and Ferauson texted his court clerk and bailiff saying: "I just lost it. I just shot my wife. I won't be in tomorrow. I will be in custody. I'm so sorry," according to prosecutors' court filings. Authorities said they

later found 47 weapons, including the gun, and more than 26,000 rounds of ammunition at his home.

After the shooting, Ferguson was arrested and initially released on \$1 million bail. He was taken back into custody last year after Judge Eleanor J. Hunter contended that he had lied about drinking alcohol while out on bond, which would violate the terms of his release. Ferguson got out of jail again in October this time on \$2 million bail. Ferguson is an elected

judge in Orange County, but he is not currently hearing cases and his name is no longer listed on the superior court's website. Under the state's constitution, a judge who faces a felony charge can continue to draw a salary but can't hear cases.

Ferguson has been a judge for a decade. He began his legal career in the Orange County district attorney's office in 1983 and went on to work narcotics cases, for which he won various awards, and served as president of the North Orange County Bar Association from 2012 to 2014.

Ferguson was admonished by the Commission on Judicial Performance in 2017 for posting a statement on Facebook about a judicial candidate "with knowing or reckless disregard for the truth of the statement," and for being Facebook friends with attorneys appearing before him in court, according to a copy of the agency's findings.

Ferguson said on his Facebook page that he grew up in a military family and traveled throughout Asia as a child. He attended college and law school in California and married his wife in 1996.

# Historic ocean liner departs Philadelphia on voyage to become the world's largest artificial reef

The historic, aging ocean liner that a Florida county plans to turn into the world's largest artificial reef departed from south Philadelphia's Delaware River waterfront on Wednesday, marking the opening segment of its final voyage.

The SS United States, a 1.000-foot vessel that shattered the transatlantic speed record on its maiden voyage in 1952, is being towed to Mobile, Alabama, for planned prep work before officials eventually sink it off Florida's Gulf Coast.

Officials have said the deal to buy the ship could eventually cost more than \$10 million. The lengthy process of cleaning, transporting and sinking the vessel is expected to take at least one-and-a-half years.

The SS United States was once considered a beacon of American engineering, doubling as a military vessel that could carry thousands of troops. Its maiden voyage broke the transatlantic speed record in both directions when it reached an average speed of 36 knots, or just over 41 mph (66 kph), The Associated Press reported from aboard the ship.

The ship crossed the Atlantic Ocean in three days, 10 hours and 40 minutes, besting the RMS Queen Mary's time by 10 hours. To this day, the SS United States holds the transatlantic speed record for an ocean liner.



# Rubio will skip a G20 meeting after calling host South Africa's policies anti-American

JOHANNESBURG (AP) — U.S. Secretary of State Marco Rubio will skip a two-day meeting of foreign ministers from the leading rich and developing nations that starts on Thursday after criticizing host South Africa's policies as anti-American.

Instead, Rubio was headed back to the United States on Wednesday from his first trip to the Middle East as America's chief diplomat after leading a U.S. delegation in talks with Russia in Riyad over the war in Ukraine.

Rubio spoke with the foreign ministers of France, Germany, Italy, the United Kingdom and the European Union's foreign policy chief to brief them immediately after Tuesday's meeting with Russian Foreign Minister Sergey Lavrov, the State Department said.

Top European diplomats, as well as Lavrov and Chinese Foreign Minister Wang Yi are all expected at the Group of 20 meeting in Johannesburg while the U.S. will be represented by a lower-level delegation.

A G20 meeting would normally be an opportunity for a U.S. secretary of state to push for support on U.S. positions, especially at the start of a new administration.

Analysts say Rubio's ab-

sence reflects the Trump administration's indifference to organizations promoting international cooperation, but Rubio has also directly rejected South Africa's priorities for its G20 presidency. The hosts have picked "solidarity, equality, sustainability" as the theme of the G20 this year.

South Africa, the first African nation to hold the group's presidency, says it will try to advance the interests of poor countries, especially

with debt refinancing and helping them mitigate the impacts of climate change, where the developing world is asking rich countries to pay

Rubio posted on X this month that he would also not attend the main G20 summit in Johannesburg in November, saying South Africa was using the gathering to promote diversity, equality and inclusion frameworks, "In other words: DEI and climate change." "My job is to advance America's national interests, not waste taxpayer money or coddle anti-Americanism,"

G20 meeting also underscores a major deterioration in U.S. relations with South Africa, one of its key trade partners in Africa.

President Donald Trump signed an executive order earlier this month stopping U.S. aid and assistance to South Africa over a land law that he says discriminates against some of the country's white minority. The order also called South Africa's foreign policy anti-American and criticized its ongoing case accusing Israel of genocide in Gaza at the United Nations' top court, and what it said was the country's closeness to the Communist Party in China. South Africa is due to hand over the presidency of the G20 to the U.S. at the end of this year, and the two countries are expected to work together under G20 protocols.

South African Foreign Minister Ronald Lamola said on Wednesday that the U.S. would be represented in Johannesburg this week "in one form or shape or another" and stressed that Rubio's decision was "not a complete boycott of South Africa's G20" by the U.S.Analysts in Africa says they still see a way for the G20 to make progress under South Africa's presidency. even with limited U.S. interest. 

# A worried NATO holds large-scale combat drills as the U.S. stance on Europe shifts under Trump

NATO members continued their largest combat exercises of 2025 on Wednesday, testing their ability to rapidly deploy large-scale forces on the 32-nation alliance's eastern border as worries grow over its most powerful member, the United States.

The drills in Romania, which borders Ukraine, come as a shaken Europe grapples with a new U.S. course under President Donald Trump. Defense Secretary Pete Hegseth has demanded that allies dramatically ramp up military spending and said U.S. security priorities lie elsewhere casting doubts on Washington's longstanding security guarantees provided to Europe. Days before the third anniversary of Russia's fullscale invasion of Ukraine, the Steadfast Dart 2025 drills comprise about 10,000 military personnel from nine nations as part of NATO's new Allied Reaction Force. They are taking place over six weeks in Romania, Bulgaria and Greece.

Although the Trump administration has not announced

plans to pull U.S. forces from the region, Hegseth's remark that "European allies must lead from the front" left NATO partners contemplating a potential new reality in which the U.S. is no longer the powerful, nuclear-armed backstop for the continent's security.

Radu Tudor, a defense analyst in Bucharest, said a U.S. rollback of its military presence in Romania would be "a gift" to Russian President Vladimir Putin.

"The whole eastern flank of NATO (would) become weaker in front of Russia's aggressive behavior," he said, adding that it would push Romania to ask NATO allies to contribute troops and weapons to plug the gap left by several thousand American troops.

Adm. Stuart B. Munsch, commander of the Allied Joint Force Command, said threats to NATO "have become increasingly complex and unpredictable" over the past decade.

"To address this complex security environment, NATO has undergone a significant war-fighting transformation. We have taken our defensive plans from concept to reality," Munsch told reporters at the training base on Wednesday.

"This exercise ... represents the culmination of our efforts and the beginning of our new force that will defend every inch of alliance territory."

European allies have also expressed concern over being sidelined from talks between Washington and Moscow's top diplomats on Tuesday in Saudi Arabia on working towards ending the war in Ukraine.

The fast-moving developments prompted France's president to convene select EU countries and the U.K. for talks this week in

Greek and Spanish marines led exercises last week in Greece, including a mock amphibious assault.

Britain leads the operation with 2,600 military personnel and 730 vehicles.

More than half a million Afghans who fled the Taliban takeover of Afghanistan in 2021 have been living without papers in Pakistan, thousands of them waiting for resettlement in the United States and elsewhere.

### Aruba's Bocas: home to the rarest fossil reefs on the planet!



(Oranjestad)—If you've been to the northern coast of Aruba already, you've probably noticed how the ground differs entirely from the sandy beaches on the southern part of the island. These hard surfaces, with sharp bumps and holes are actually fossilized coral reefs, of which its growth and changes can be traced back to the last glacial period.

On May 30 2023, geoscientists, Dr. Patrick Boyden from the Marum research faculty at the University of Bremen, Prof. dr. Alessio Rovere from the Ca' Foscari University of Venice and Prof. dr. Gianfranco Scicchitano, from the University of Bari Aldo Moro, presented their research on these fossilized coral reefs at the University of Aruba. Their focus for their research included studying the health and formation patterns of these coral reefs, and to investigate how these reefs have responded and can respond to fluctuating sea levels or extreme weather, like hurricanes and tsunamis.

Through underwater and land surveillance, and 3D models of the reefs, they were able to narrow down when these formations started to take place. They were also able to track the fluctuation of sea levels during the past hundred or even thousands of years, and the effects that this fluctuation has had on the coral reefs of the windward side of Aruba.

These findings can certainly put things into perspective. The ground on which we have walked many times in the northern part of the island hold such rich history, history that dates back to a time that most of us cannot even imagine. As the scientists themselves have pointed out, these fossilized reefs on the windward side are truly an incredible and rare remnant of geological history, as they provide a clear view of how these reefs have formed.

This research is also important for the future of coral reefs on the island. By studying rising sea levels and climate impact on these coral reefs, we are able to take concrete action in protecting and preserving our coral reefs. So, if you are ever visiting one of the bocas or driving along the northern part of the island, please be conscious to help protect our natural historical remnant. Oh, and wear (coral-friendly) sunscreen!



### Aruba's Nature is to be Cherished

ST. CRUZ — The national park Arikok comprises almost 18 % of the island. Its rugged terrain, desert-like hills filled with tall cacti, breathtaking coastline and protected local flora and fauna welcome you to be explored. There is numerous wildlife to discover like for example the sea turtle who lays his eggs on the park's beaches. There are more places on the island that are a preserved area like the Bubali Plas which is a bird sanctuary.

The national park Arikok



takes you on a memorable journey of the islands past offering unique geological, cultural and historical sites. These can all be enjoyed and explored either on your own or during guided tours. A wide variety of educational and informative programs and fun activities is available.

Did you know that four of the in total seven species of sea turtle lay their eggs on Aruba's beaches? In the national park, a Least Tern (Sternula antillarum) keeps a strict eye on a very special event taking place below on the beach: a majestic Leatherback (Dermochelys coriacea) heads back to sea after laying her eggs, while another nest laid 2 months ago by the same female hatches. A very rare occurrence of daytime nesting and hatching. Sea turtles prefer nesting in the cool and dark hours of the night. And hatchlings usually wait for the cue of cooling surface sand before emerging.

#### **Bubali Magic**

This beautiful close-up image of the pink bird is courtesy of Michiel Oversteegen of the Aruba Birdlife Conservation. This important foundation showcases and builds awareness of Aruba's birds and other native flora and fauna. You may have seen a 'pink cloud' lately at the Bubali or Spanish Lagoon Wetlands areas? It's most likely to be Roseate Spoonbills (Ajaia ajaja) or 'Chucharon Cora' as they are known in Papiamento. This unusual looking bird forages in shal-



low muddy water while sweeping its flattened bill from side to side to catch small fish, crustaeceans and other aquatic invertebrates. The Roseate Spoonbill remains an uncommon sight as they are vulnerable to degradation of feeding and nesting habitats (Wetlands). (Source: arikok national park)

Motorized vehicles are forbidden to drive on the sand dunes in the Northern part of the island and all beaches in Aruba are forbidden for any motorized vehicle. 
# Feeling parched? Grab a refreshment by the side of the road!

# The stories of "Compa Nanzi"

(Oranjestad)—The most popular character you may hear about in the Caribbean is Anansi, known locally on Aruba as "Compa Nanzi". Local children grew up hearing the tales of the conniving spider, and his legacy forms part of the oral narrative tradition that is common in Aruba.

Although the stories are most popular in the Caribbean, "Compa Nanzi" is not entirely unknown globally, especially not in the West African region. Brought to the "new world" by enslaved Africans from Ghana, the historical thread of how Nanzi was introduced on Aruba follows the enslaved Africans in Curacao during the colonial era, which saw the biggest population of enslaved Africans in the Dutch Caribbean.

The stories of Compa Nanzi were a sign of hope for freedom among the slaves, who passed around different stories involving the famous spider through word of mouth, due to not being able to express their native culture in the new world. These stories were a way to not only preserve their culture, but it acted as a medium for relief during the harsh treatment to which they were subjected to.

It wasn't until the end of the nineteenth century that the stories of Nanzi were written down in different languages. However, not all stories are completely alike in every country, as is the risk of oral story telling. However, one thing will always be dominant in Compa Nanzi's stories: his sneaky ways to get what he wants!

How Nanzi fooled the king One day Nanzi was taking a stroll near the castle of Shon Arei, the king. He had this sudden urge to walk in. He didn't think too much about it and committed to what he had in mind. It was a warm afternoon, and the castle personnel were taking their afternoon nap. Even the soldier guarding the castle door was fast asleep, snoring so loud that his beard bounced up and down on his chin. Nanzi just slipped past him, looked

back for a moment then walk right on in.

Nanzi stumbled upon the king's quarters. With all his excitement he sat in the king's throne, and put on his crown that was hanging on the side of the throne. It was very hot that day, and it wasn't long until Nanzi too fell asleep, right there on the king's throne. He was so deep in sleep and snoring so loud, that even when the king found him in his seat, Nanzi did not even notice.

What is that he hears? A herd of sheep walking by? "Compadre, listen here!" Nanzi screamed as loud as he could. The sheep herder got close to the sack. "What is this?"

"Man, there is something very beautiful in here that you can see. It's very rare and strange, but indeed, there is something so beautiful in here that you've never seen or will ever see," Nanzi told the herder.

## Basic driving rules on Aruba: Traffic signs

(Oranjestad)—Safe driving is an speed limit on the island is 50 and important part of any (off) road trip. That is why we want to offer you tips and tricks when it comes to driving on the roads and highways of Aruba. Today, we'll take a look at traffic signs.

#### Speed limit in certain areas

As mentioned in yesterday's issue, the legal minimum and maximum 80 km/h respectively. However, there are some areas where it is mandated to drive up to a certain speed. This is always indicated by a circular traffic sign with red border and the number 50 on it. Signs like these are always paired by a similar sign with the number crossed out further down the road. This means that the mandate for this speed is now over; you may in-

or triangle—usually signal a warning, prohibition or preference.

Besides the "50" sign, you may also encounter a traffic sign that says "bebouwde kom". These can be found in San Nicolas and Oranjestad. Bebouwde kom sings are rectangular and blue, and essentially tell you that you are in a heavily in-

crease your velocity. Red borders habited area. The maximum speed on traffic sign—whether it's a circle limit in a bebouwde kom is 50 km/h. Just like the previous pair, bebouwde kom signs are also paired with a similar sign crossed out.

#### **Priority signs**

On the main roads of Aruba (not the highways), you may see a yellow, squared sign with a white border. This sign tells you that on this road, you have priority and all other traffic should yield to you. This sign can be seen in Savaneta for example. So, if you are driving on the main road in Savaneta going to San Nicolas, you are driving on a single long road, and other cars that want to get on this main road or cross it, either from an intersection or from a dirt road, must all wait until traffic on the main road is clear. In other words, you do not have to stop for them. This sign too has a counter part that indicates that your priority is over.

Another priority sign you may encounter is a triangle sign with a red border and something that looks like a cross. You'll see this sign in an intersection. The general rule of thumb for crossing an intersection that do not contain traffic lights, roundabouts, sign or arrows on the road, is to always yield for traffic on your right. However, if you encounter this sign on your side of the intersection, you have priority over the other cars, even the one on your right.

However, be careful not to confuse this sign with a similar up-side down triangle, also found on intersections. This sign is a prohibition sign, telling you that you have to stop and give other cars priority. Of course you also have a "stop" sign that mean the same thing. The stop sign is generally used for tricky intersections with minimal view of opposite incoming traffic.

These are some of the basic rules that you would have to know if you decide to drive on the island. These are of course other traffic signs, and we recommend you visit aruba-travelguide.com for an extensive overview of all traffic signs used on Aruba.





# How to set and invest your emergency fund

Emergency funds are an absolutely crucial aspect of any financial plan, regardless of the life stage or situation.

For people who already high-interest-rate have debt, having an emergency fund can help guard against resorting to additional high-cost financing in a pinch. It also helps you defray unexpected expenses without needing to raid your retirement accounts.

Finally, the big reason to have an emergency fund is to cover your basic costs in case of job loss.

#### Step 1: Determine your monthly living expenses

Tally up your essential monthly outlays: housing costs, utilities, food expenses, servicing debt, insurance, and taxes. Don't include nonessential items that you could live without in a pinch.

Multiply your essential living expenses by three months. This is your absolute minimum savings target for your emergency fund.

From there, you can customize your own emergency-fund amount upward. One of the biggest determinants of emergencyfund size is your career path. Contractors or other workers with lumpy income streams should obviously

Subtract the figure from Step 2 (your current emergency fund) from the figure in Step 1 (your target emergency fund). This is how much you need to save at a bare minimum double this level or more. Setting money aside to hit this savings target should be your main savings priority in the months ahead.

#### Step 4: Identify appropriate investments

My advice is to use plainvanilla cash investments: checking and savings accounts, CDs, and money market accounts. Online savings accounts are often one of the highest-yielding cash options; credit unions also frequently offer decent yields.

As you shop for cash options to populate your emergency fund, remember that not every product type is FDIC-insured. Money market mutual funds, for example, do not qualify for FDIC protection though, in practice, they've been quite safe. And remember that CDs carry penalties if you need to get your money out prematurely.

#### Step 5: Find the right receptacle

Finally, being able to access emergency-fund assets in a pinch is crucialyou don't want to have to deal with taxes or penalties. For that reason, it's ideal to maintain your emergency fund outside the confines of your retirement accounts. However, your Roth IRA can help back up your emergency fund, if need be. While it's not ideal to use your retirement savings as a piggy bank, you can tap Roth IRA contributions at any time and for any

If you're a homeowner, it can make sense to augment your emergency fund by setting up a home equity line of credit to use in case of emergency.  $\square$ 

# Apple unveils a souped-up and more expensive version of its lowest priced iPhone

Apple has released a sleeker and more expensive version of its lowest priced iPhone in an attempt to widen the audience for a bundle of artificial intelligence technology that the company has been hoping will revive demand for its most profitable product lineup.

The iPhone 16e unveiled Wednesday is the fourth-generation of a model that's sold at a dramatically lower price than the iPhone's standard and premium models. The previous bargain-bin models were called the iPhone SE, with the last version coming out in 2022.

Like the higher-priced iPhone 16 lineup unveiled last September, the iPhone 16e includes the souped-up computer chip needed to process an array of AI features

that automatically summarize text, audio and create on-the-fly emojis while smartening up the device's virtual assistant, Siri. It will also have a more powerful battery and camera. All those upgrades will translate into a higher starting price for an iPhone 16e at \$600, a 40% increase from \$430 for the last iPhone SE. But iPhone 16e will be more affordable than the cheapest standard iPhone 16 at \$800. The new phone will be available in stores Feb. 28, but can be pre-ordered beginning Friday. "We're so excited for iPhone 16e to complete the lineup as a powerful, more affordable option to bring the iPhone experience to even more people," said Kaiann Drance, an Apple vice president in charge of promoting a device lineup that accounts for more than half of the company's revenue.

# A home game for San Antonio, a homecoming for Kevin Durant when Suns and Spurs meet in Austin

Kevin Durant went back to the Bay Area last weekend. He's now going back to school.

A nostalgic time for Phoenix's All-Star forward continues Thursday, when Durant and the Suns play San Antonio in Austin, Texas — a home game for the Spurs and a homecoming for Durant, since the game brings him back to where he played his one college season with the Longhorns. "It does mean a lot to me," Durant said. "I'm excited that we get to go back to play a regular-season game there. Austin is a place where I kind of started this journey, and to have so many friends and family that are still there from, what, 16, 17 years ago is pretty sweet. So, I appreciate the NBA for setting this up. This is a unique time." Durant's lone season in Austin was 2006-07, and he was college basketball's best player that year. He averaged 25.8 points and 11.1 rebounds, finishing

the season ranked fourth

nationally in both of those categories on his way to being selected as player of the year by The Associated Press and a number of other outlets. He declared for the draft after that season, went No. 2 overall to Seattle in 2007 and the accolades keep piling up. Du-

rant is the only men's player in USA Basketball history to win four Olympic gold medals, he won two championships with Golden State returning to the Bay this past weekend after being selected as an All-Star for the 15th time and just became the eighth player

in NBA history to eclipse the 30,000-point mark.

"I think it's an awesome opportunity for himself and for the city of Austin to come out and support one of our great players who is still in the prime of his career right now," Texas coach Rodney Terry said. "He's scored

over 30,000 points, he's one of the all-time scorers at the next level, one of the all-time scorers at the collegiate level. But to have an opportunity come back where you played colleaiately, to play a professional game against one of the best organizations in all of professional sports in the Spurs, you can't ask for a better scenario."

This is the third consecutive season where the Spurs have played two home games in Austin, about 75 miles northeast of San Antonio. The Spurs see Austin as part of a mega-region that they've been cultivating for years, even stretching into Mexico and this year's home games help break up the annual rodeo road trip. The San Antonio Stock Show and Rodeo typically sends the Spurs on the road for much of February, so this year's games in Austin break up that window.

The Spurs also play in Austin on Friday against Detroit. The Suns got to Austin on Tuesday and one of Durant's first stops was the Longhorns' practice.

# Researchers confirm Hall of Famer Bobby Hull had CTE when he died 2 years ago

CHICAGO (AP) — Bobby Hull, the Hall of Fame forward and two-time NHL MVP who helped the Chicago Blackhawks win the Stanley Cup in 1961, had chronic traumatic encephalopathy when he died two years ago, his widow said in a statement released on Wednesday. Researchers at Boston University's CTE Center found that Hull had stage 2 CTE when he died in 2023. He was 84.

paired judgment over his final decade. He chose to donate his brain after seeing former teammate and fellow Hall of Famer Stan Mikita decline late in his life.

"Seeing the pain and

heartache suffered by his lifetime friend Stan Mikita's family, Bobby felt strongly no other family should have to endure CTE," Deborah Hull, his wife of 39 years, said in a statement. "He insisted on donating his brain, feeling as though it was his duty to help advance research on this aaonizing disease."

Nicknamed "The Golden Jet" for his speed and blond hair, Hull was one of the most prolific forwards Hull struggled with short- in NHL history, scoring 610 term memory loss and im- times over 16 seasons with Chicago, Hartford and Winnipeg. He dazzled generations of Blackhawks fans with his shooting and skating skills and remains franchise's career leader with 604 goals. Hull also had 303 goals while


"We are grateful to Bobby Hull and all of the NHL players and families who are helping us learn how to prevent, diagnose, and treat CTE," said Dr. Ann McKee, director of the Boston University CTE Center. "We encourage retired players and their families to reach out for help and care if they are concerned about CTE, as we are learning how to effectively treat symptoms, especially in mid-life.

National The League Players' Association announced in November it was forming an advisory committee to help hockey players better understand CTE and

the damage that concus-In December, researchers at Boston University published a study of deceased male hockey players that showed 18 of the 19 NHL players examined including Hull, Mikita, Ralph Backstrom, Bob Probert, and Derek Boogaard had CTE.

It also found the odds of developing CTE increased by 34% for each year of hockey played.

A degenerative brain disease, CTE has been identified in athletes and military combat veterans who sustained concussions or repeated blows to the head.

# Players and coaches among those who favor seeing MLS shift to an international calendar

As Major League Soccer readies to open its 30th season, some players and coaches are advocating for a fall-to-spring calendar, a major move that would align the league with its international counterparts.

Such a shift would give MLS a more competitive position for player transfers, while also freeing up players for club duty during the summer, when many major global tournaments take place.

But there are obvious challenges, like the weather during a season that begins in late February and runs through the playoffs to December.

Teams like Minnesota United and the Chicago Fire

already face downright hostile weather during the winter months.

On Tuesday night, when the Colorado Rapids beat LAFC in a CONCACAF Champions Cup match in Denver, temperatures hovered in the single digits. Frigid temperatures were expected for the Champions Cup match on Wednesday in Kansas between Lionel Messi's Inter Miami and Sporting KC.

"We experienced the game in Chicago last year at the beginning where it was 15-10 degrees cold. But I think once the players got going, you still saw a game with intensity and tempo and, you know, I don't think you see it at the same level in a lot of those summer matchups. I know it's not (popular) across the board, but I like the idea," said FC Cincinnati coach Pat Noonan.

With a warming climate, some of those midsummer games in places like Texas become difficult, too. Last season, a match in Austin was pushed back because of extreme heat.

MLS opens its new season Saturday, and it certainly won't be balmy in those northern states. But the current schedule allows the league to mostly avoid the months when the NFL and the college football post-season rule.

"MLS has done a great job of understanding what the United States is like," Seattle Sounders coach Brian Schmetzer said.

"It's just bigger and it's got more diversity and climate and all of those things.

And you have to take all that into consideration, because we won't be able to play in some markets during those winter months."

If MLS aligned with Europe, the season would probably open in mid-August with a break in mid-December before resuming in February. The championship would likely be in May.

Noonan and Houston Dynamo general manager Pat Onstad both said aligning with international leagues would make it easier for teams to bring in top talent.
